are held and firmly bound unto the New Jersey Division of Consumer Affairs, Department of Law and Public
Safety, as Obligee, in the penal sum of Ten Thousand Dollars
(\$10,000.00), for the payment of which we hereby bind ourselves, our heirs, executors and
administrators, jointly and severally, firmly by these presents.

WHEREAS, the Principal is a contractor business that is engaged in home improvement or home elevation
services; and

WHEREAS, the Principal is providing this bond in accordance with its obligations set forth in the Contractors'
Business Registration Act, N.J.S.A. 56:8-136 et seq. (the "CBRA").

NOW, THEREFORE, THE CONDITIONS OF THIS OBLIGATION ARE SUCH, that if the Principal shall pay all
penalties assessed by the Obligee for violations of the CBRA, then this obligation shall be null and void;
otherwise to remain in full force and effect.

This bond is for a definite term beginning January 19, 2025, and ending January 19, 2026,
and may be continued at the option of the Surety by Continuation Certificate.

PROVIDED, that regardless of the number of years this bond is in force, the Surety shall not be liable hereunder
for a larger amount, in the aggregate, than the penal sum listed above.

PROVIDED FURTHER, that this bond shall not be payable for treble damage claims pursuant to N.J.S.A. 56:8-
1 et seq.

PROVIDED FURTHER, that cancellation or nonrenewal of this bond shall not be effective unless and until at
least 10 days' notice of intention to cancel or nonrenew has been received in writing by the Principal and the
Obligee from the Surety.

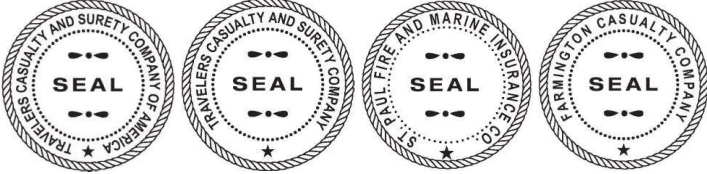


